SOCIAL EVENTS: The Board sent several emails encouraging owners to step up and volunteer to serve as a member of the Social Committee. This unresponsiveness has unfortunately given the impression that the residents of Meridian have been comfortable with not having any social events, and regretfully there have not been any.

WHY A STUDENT AFFAIRS COMMIT-

TEE2: A major goal of the Student Affairs committee is to keep all Meridian parents informed of certain school activities, especially since Meridian has at least six public schools represented in our community as well as several private schools and families who home school. This committee would be a link between our students, their schools and their community.

<u>REQUEST FOR SUPPORT</u>: We do not want to give up on the Student Affairs committee as we have many bright and talented students in this community. We have so many schools, and many students never have the opportunity to get to know each other and share their common interests. Therefore, it is still not too late.

NEW ARCHITECTURAL COMMITTEE <u>**MEMBERS: HOORAY!!!!**</u> – A new Architectural Committee ("ACC") was recently formed after owners were asked to nominate themselves or their neighbor to serve. Each candidate was able to meet with the board prior to the selection process. This newly formed ACC committee of five is headed by Shirish Damle from the BOD. The ACC's job is to ensure our community maintains a degree of conformity in the exterior appearance of our homes.

Therefore, before you begin to make any changes, additions, or alterations to your home and/or property, Meridian's CCR's require approval from the ACC. To obtain the ACC's approval, all owners are required to complete and send their improvement request's to the ACC. The ACC Form is available at our website.

The new Architectural Committee Members are committed to serve all owners and keep within the timeframe of thirty (30) days to review each owner's improvement request forms, drawings, surveys, etc. If owners are able to submit all the necessary documentation timely, the ACC request could be expedited sooner than thirty (30) days.
